MINUTES OF COURSE No. 328

BRAZILIAN ORIENTEERING CONFEDERATION (BOC) MAP MAKER'S COURSE - LEVEL III

On the twenty sixth day of May two thousand and eleven, at seven thirty AM, the following people met at the Staff Support Battalion (SSV - Bat), placed at 163, Verlengde Gemene Lands Weg Street, in Paramaribo-Surinam: Mr. CARLOS ALBERTO XAVIER, registered in the Brazilian Orienteering Confederation Map Committee under No 10/7, course instructor and the students registered to attend the BOC Orienteering Map Maker's Course-Level II, Mr. LUIZ SERGIO MENDES, from the Brazilian Orienteering Confederation Map Committee, Mr. LEONARDO JORGE ANDRÉ DE BARROS, Brazilian Army First Sergeant, Sports Assistant for the Surinamese Armed Forces, Mr. WILSON BALANSI, Mr. MAIKEL MAARTEN COMVALIUS, Mr. GIOVANNI MANUEL BRUNST, Mr. DANNY IVAN DWARKASING, Mr. JACQUES BRYAN CHAAR, Mr. RUDY WILFRED KUHN, Mr. LUCIEN RICARDO VROOM and Mr. STEVEN ALBERT JACOTT, all Surinamese Army Sergeants. This meeting is organized for the opening ceremony and for starting the Brazilian Orienteering Confederation Map Maker's Course Level III to be carried out from May 26th to 28th, two thousand and eleven, with a 22-hour workload. Beginning the course activities Mr. CARLOS ALBERTO XAVIER invited Mr. LUIZ SERGIO MENDES to be the course secretary. Next, the instructor thanked the students presences, confirmed their registration and presented a summary of the course activities, and then made a comparison among the three course levels and pointed out the importance of these courses in the formation of the Orienteering map makers and the first O Maps to be made in Surinam, which will provide support for training the country's first Orienteers. Next, the instructor handed in the student's booklets and other course material and as nothing remained to be discussed the instructor officially began the classes.
